

Antimony Resource increases 66% to 14,500t & Global MRE exceeds 1.4 Moz AuEq



Siren Gold Limited (ASX: SNG) (Siren or the Company) is pleased to provide an update on its Auld Creek Project in Reefton.

Highlights

- The updated Auld Creek Mineral Resource Estimate (MRE) has increased to 210koz @ 7.7g/t AuEq containing 105koz @ 3.84g/t Au and 14.5kt of antimony @ 1.7% Sb.
- The updated Auld Creek MRE represents an increase of 38koz (+58%) of gold and 5.8kt (+66%) of antimony.
- The MRE comprises the Fraternal and Bonanza East Shoots only and is based on existing surface trenches and includes the drilling carried out in early 2024.
- Resource is currently defined to approximately 150m below surface and remains open at depth.
- Siren's Reefton Project MRE now stands at 483koz of Au and 14.5kt of Sb for 588koz @ 4.7 g/t AuEq.
- Siren's Global MRE (including Sams Creek) now stands at 1.31Moz of Au and 14.5kt of Sb for 1.41Moz @ 3.4 g/t AuEq (100% basis).

Siren Managing Director and CEO, Victor Rajasooriar commented:

"The updated Reefton MRE of 588koz AuEq, positions the project to be further drilled and developed, with only a small drilling program having been carried out in 2024. The Auld Creek project has only been drilled to approximately 150m below surface and the potential to grow that further is outstanding given the mineralisation trend continues at depth. The antimony resource having increased by nearly 66% positions Reefton to be a potential supplier of antimony to western countries and could fast track New Zealand as the next producer of this critical mineral.

New Zealand has just produced a draft Critical Mineral List. Included on the list are minerals that will be used around the world to build technology, and support a clean energy transition, with Antimony ranked at No 5 on the list. The work being done by the New Zealand Government to map out minerals, classify which are critical, and develop a strategy to encourage growth and investment in mining is a big step forward for both the industry and the Country. This is a positive signal that New Zealand has a role in the global supply chain for critical minerals and the Company continues working with all stakeholders to extract full value from its Reefton Project".

Background




Figure 1. Reefton area showing Auld Creek Project, and surrounding gold and coal mines.

The Auld Creek Prospect is contained within Siren's Golden Point exploration permit and is situated between the Globe Progress mine, which historically produced **418koz @ 12.2g/t** Au, and the Crushington group of mines that produced **515koz @ 16.3g/t Au** (Figure 1). More recently OceanaGold (OGL) mined an open pit and extracted an additional 600koz of gold from lower grade remnant mineralisation around the historic Globe Progress mine. Collectively these mines produced **1.6Moz** at **10g/t Au**.

In August 2023 (see Announcement date 21 August 2023) Siren estimated the Maiden Auld Creek MRE of **66koz @ 3.5g/t Au, 8,700t @ 1.5% Sb**. This estimate was for the **Fraternal Shoot** only.




Figure 2. Auld Creek drillhole plan and MRE limit.

Since the Maiden MRE was announced drilling at Auld Creek continued to largely target the Bonanza East Shoot (Figures 2 – 4). Significant drillhole intersections completed since the August 2023 maiden MRE are shown in Table 3.




Figure 3. Schematic Bonanza East Long section.




Figure 4. Schematic Fraternal Long section.

Updated Mineral Resource Estimate

Siren has completed an updated Auld Creek mineral resource estimate (MRE) based on an underground mining scenario. The MRE, which is in accordance with the JORC 2012 Code, has utilised geological and assay data from 3,340m of diamond core drilling from 27 drillholes and 11 trenches totalling 107.7m.

Siren is using a gold equivalent formula of AuEq = Aug/t + 2.25 x Sb%, based the average metal prices for the last 12 months of US\$2,160 per ounce of gold and US\$15,625 per tonne of antimony. Current prices are approximately US\$2,500 per ounce of gold and US\$25,000 per tonne of antimony. Metallurgical recoveries of 85% were used for both gold and antimony based on metallurgical testwork results announced in September 2024 (see Announcement dated 05 September 2024).

Details regarding the estimation of the Mineral Resources for the Auld Creek Project are provided in the attached JORC Table One.

Geology and Geological Interpretation

Geological interpretation is based on available field mapping data, structural mapping, drillhole lithology and grade data. Modelling was completed using Leapfrog Geo modelling software. Mark McCulloch carried out wireframing, geological modelling and estimation. Two mineralised grade domains were used based on the Fraternal and Bonanza East Shear Zones.

The mineralised domains were defined using both the drillholes and trenching in the database, intercepting the modelled mineralised domain. Geological mapping and trenching completed by Siren defined the surface trace of the mineralisation. Drillhole cross-sections and geology 3D modelling by Siren geologists were also used to guide the geological interpretation of the mineralised zones.

A nominal cut-off grade of 0.50g/t AuEq was used to guide the continuity of the mineralised wireframes; however, at the modelling geologist's discretion, intervals of 0.50 g/t AuEq were omitted from wireframes (e.g. at the periphery of mineralisation). The east-dipping Bonanza mineralised structure intercepts the Fraternal Shear and is included in the model.



Mineralisation domain wireframes were modelled using the Leapfrog Geo Vein System modelling technique. An oxide wireframe was designed based on the weathering logged in the drillholes. Density data for waste and mineralisation was collected during Siren's drilling programs at both Auld Creek and other Reefton gold projects. No densities were taken in weathered rock at Auld Creek. The geology is very similar to Siren's Big River and Alexander River Reefton projects, and oxide densities from these projects were used.

No historical mine workings are found in the Fraternal Shear, while the Bonanza East Shear has a single exploration drive, but the exact location of it is uncertain.

Sampling and Analysis

Selective sampling of drill core was completed where mineralisation was geologically logged with intervals selected for sampling were photographed and cut into half (along the axis of the core). Generally, 1m intervals were sampled, ensuring all orientation marks were retained. This methodology of sampling drill core is industry standard and deemed appropriate. Trench sampling was based on 1m intervals unless dictated by geology.

Estimation Methodology

For this resource estimate, Siren has completed the following:

- Geological interpretation and wireframing in Leapfrog Geo based on AuEq data;
- Hard boundary compositing in Leapfrog Edge Module (Leapfrog Edge);
- Variography and Ordinary Kriging in Leapfrog Edge; and
- Block Model Estimation in Leapfrog.

Au and Sb were estimated individually, and the AuEq was calculated from these results. Composites for each element were based on 1m composites. Outlier grades were assessed by reviewing composite histograms of gold grades. Extreme outlier grades in Au in the Fraternal were identified, and this was controlled by using the Leapfrog outlier tool in estimation. Other variables and domains determined that no top-cut was required.

An estimation domain was created for the Fraternal and Bonanza East mineralisation shear zones. The hard boundary domains were based on a 0.5g/t AuEq cut-off.

Individual domain search distances, number of passes, minimum and maximum sample numbers, block size, variography and Exploration Data Analysis (EDA) are outlined in the Auld Creek Mineral Resource Estimate Report and summarised in JORC Table 1.

Block model validation included block statistics review, declustering means, swath plots, and visual inspection of grade distribution against composites. Sensitivities to block size, domain boundaries, and estimation parameters were undertaken.

Cut-off Grades

The MRE has been reported at a 1.5g/t Au cut-off grade, which Siren considers appropriate for an underground mining operation.

Siren is using a gold equivalent formula of AuEq = Aug/t + 2.25 x Sb%, based the average metal prices for the last 12 months of US\$2,160 per ounce of gold and US\$15,625 per tonne of antimony.

Mining Factors

The MRE has been completed with the assumption that it will be mined using underground mining methods. No other detailed assumptions have been made to date. Metallurgical recoveries of 90% for



both gold and antimony based on metallurgical testwork results announced in September 2024 (see Announcement dated 05 September 2024).

Classification of Mineral Resource Confidence

The Auld Creek MRE has been classified by the independent Competent Person as 'Inferred' based on the current understanding of geological and grade continuity and drill density. The classification reflects the Competent Person's confidence in the location, quantity, grade, geological characteristics and continuity of the MRE. The MRE has been classified as Inferred based on the following relevant factors:

- Drillhole and trench spacing, and
- Structural controls and geological continuity

The data spacing and distribution are sufficient to establish geological and grade continuity appropriate for Mineral Resource estimation and classification, and the results appropriately reflect the Competent Person's view of the deposit.




Figure 5. Fraternal Long Section with AuEq block model overlaid.

The MRE with Au g/t, Sb % and AuEq g/t at a 0.0 g/t, 1.0g/t and 1.5g/t AuEq cut-offs are shown in Table 4. The MRE split by domain at a 1.5g/t cut-off is shown in Table 5. Images of the block model for AuEq are shown in Figures 4 and 5.

The updated Auld Creek MRE represents an increase of 38koz (+58%) of gold and 5.8kt (+66%) of antimony.




Figure 6. Bonanza East Long Section with AuEq block model overlaid.
